(a) Any pharmacy engaged in compounding shall maintain written policies and procedures for compounding that establishes procurement procedures, methodologies for the formulation and compounding of drugs, facilities and equipment cleaning, maintenance, operation, and other standard operating procedures related to compounding.

Non-sterile preparations can be categorized as simple, moderate or complex 3 (as outlined in United States Pharmacopeia (USP) Chapter <795> Pharmaceutical Compounding - Nonsterile Preparations).
