Highlight the urgency and state significant findings for the problem based on the data. Objectivity is your priority, so resist the urge to overstate. •Analyze—do not merely present—the data.

In the header of each page you include the paper title and page number. If your paper title is longer than 50 characters you should use a shortened version as running head. The page number should be positioned in the top right-hand corner. On the title page the APA running head is preceded by the words "Running head:".

Your title page should include a page number, article title, author name, and author affiliation. The seventh edition of the APA Publication Manual contained a few changes to the format of an APA style title page, including separate guidelines for student and professional title pages. Double-space the entire research paper, including quotations, notes, and the list of works cited. Indent the first line of a paragraph half an inch from the left margin. Indent set-off quotations half an inch as well (for examples, see 76-80 in the MLA Handbook).
